

社團法人中華民國國立臺灣師範大學物理系系友會
國際交流活動獎學金辦法

- 一、 設立宗旨：為獎助母系表現優良學生赴國外大學(機構)研修，鼓勵學生走向國際、擴展視野及提升競爭力，特設立國際交流活動獎學金（以下簡稱 本獎學金）。
- 二、 經費來源：本獎學金的經費來源為「社團法人中華民國國立臺灣師範大學 物理系系友會」之系友指定捐款。本獎學金由母系 66 級連水池系友及 67 級 張月娟系友發起捐贈，鼓勵各屆系友響應以充實本獎學金來源。
- 三、 獎助之研修方式：
 - (一) 雙聯學位（含修學分）
 - (二) 短期研修
 - (三) 交換生
 - (四) 參加研討會發表研究論文
 - (五) 移地研究，從事與所學相關之研究
- 四、 申請資格：母系學士生、碩士生及博士生，符合以下情形者。
 - (一) 申請及受補助期間需為母系已註冊之在學學生（在校生）
 - (二) 具中華民國國籍，且在臺灣地區設有戶籍之本國學生
 - (三) 未曾或未同時領取政府預算所提供累計逾一年以上留學獎助金者
 - (四) 申請者之前 1 學期在校學業成績學期等第制學業平均積分（GPA）3.00（含）以上，申請者其他綜合表現亦納入考量。
 - (五) 碩士生及博士生若屬未修課者，須有指導教授推薦並發表論文篇數相關資料
 - (六) 移地研究者，須持有指導教授與國外學校教授簽訂共同指導協定者
- 五、 獎助金額：本獎學金每年獎助總金額以 10 萬元為限。每名學生獎助金額考量其申請之學校、地區、學費、研修期間及家庭狀況等因素，酌予調整獎助額度，於審查委員會決議之。
- 六、 審核作業由物理學系學術委員會審核。
- 七、 申請時程：獲得國外大學（機構）入學研修許可或國外研討會主辦單位之 邀請函時，即可向母系辦公室提出申請。
- 八、 申請應備文件：
 - (一) 申請表
 - (二) 在校歷年成績單
 - (三) 教授推薦信
 - (四) 交流活動證明文件：研修計畫書、國外大學（機構）入學研修許可、國外研討會主辦單位之邀請函或論文被接受之證明文件影本、或指導教授與國外學校教授共同指導協定書（僅移地研究者提供）。
 - (五) 其他有助於審查之文件
- 九、 返國後一個月內須繳交心得報告乙份，並檢附相關單據以便核銷。
- 十、 本辦法如有未盡事宜，本會保留變更及修改之權利。

National Taiwan Normal University, Department of Physics Alumni Association International Exchange Activity Scholarship Regulations

Approved after revision at the Fifth Interim Meeting of the Board of Directors on April 16, 2019

Approved after revision at the Third Meeting of the Seventh Board of Directors on September 9, 2024

- I. Purpose: To support outstanding students from the Department of Physics to pursue further studies at universities (institutions) abroad, encouraging them to engage with the world, broaden their horizons, and enhance their competitiveness, the International Exchange Activity Scholarship (hereinafter referred to as the "Scholarship") is established.
- II. Funding Source: The scholarship is funded by designated donations from alumni of the "National Taiwan Normal University, Department of Physics Alumni Association." This scholarship was initiated by alumni Lian Shui-chi, Class of 1977, and Zhang Yue-juan, Class of 1978. Alumni from all classes are encouraged to contribute to this scholarship.
- III. Study Types of Scholarships:
 - (1) Double Degree (including credits)
 - (2) Short-term Study
 - (3) Exchange Student
 - (4) Participation in a seminar and presentation of a research paper
 - (5) Off-site research related to the subject of study
- IV. Application Eligibility: Bachelor's, Master's, and Doctoral students of the parent institution who meet the following conditions.
 - (1) Must be a registered student (current student) of the parent institution during the application and grant period.
 - (2) Must be a Taiwanese national with household registration in Taiwan.
 - (3) Must not have received or have not concurrently received government-funded study abroad scholarships for more than one year.
 - (4) Applicants must have a GPA of 3.00 or higher in the previous semester. Other comprehensive performance of the applicant will also be considered.
 - (5) Master's and doctoral students who have not taken any courses must provide a recommendation from their advisor and relevant documentation of the number of papers published.
 - (6) Applicants for overseas research must hold a co-advisory agreement signed between their advisor and a professor at the overseas institution.
- V. Scholarship Amount: The total annual scholarship award is capped at NT\$100,000. The amount for each student will be adjusted based on factors such as the institution of application, region, tuition, duration of study, and family circumstances. The amount will be determined by the review committee.
- VI. Applications will be reviewed by the Academic Committee of the Department of Physics.
- VII. Application Deadline: Applications can be submitted to the home department office upon receiving admission and study permit from a foreign university (institution) or an invitation letter from the organizer of an overseas seminar.

VIII. Required Documents:

- (1) Application Form
- (2) Academic Transcripts
- (3) Letter of Recommendation from Professor
- (4) Documentary Evidence of Exchange Activities: Study Plan, Admission Permit from a Foreign University (Institution), Invitation Letter from the Sponsor of a Foreign Conference, or a Copy of Acceptance Certificate for a Paper, or a Joint Supervision Agreement between the Supervising Professor and a Professor at the Foreign University (for International Researchers only).
- (5) Other Documents Assisting with Review

IX. Within one month of returning to your country, you must submit a research report and attach relevant receipts for verification.
